

SUMMARY ANNUAL REPORT

For SUFFOLK UNIVERSITY HEALTH AND WELFARE BENEFIT PLAN

This is a summary of the annual report of the SUFFOLK UNIVERSITY HEALTH AND WELFARE BENEFIT PLAN, EIN 04-2133255, Plan No. 504, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

SUFFOLK UNIVERSITY has committed itself to pay certain self-insured Medical and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with NEW DIRECTIONS BEHAVIORAL HEALTH, EYEMED VISION CARE ON BEHALF OF FIDELITY SECURITY LIFE INSURANCE CO., and STANDARD INSURANCE COMPANY to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Accident, and Critical Illness claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$729,170.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$576,205 and the total of all benefit claims paid under these contracts during the plan year was \$1,112,831.
